While it is the desire of the School Board to hire the most qualified candidate for a vacant position, on occasion, waiting until the next scheduled School Board meeting to fill a vacancy may cause an undue hardship on the division or cause a candidate to withdraw from consideration in favor of a competing offer.

This resolution is being introduced to allowthe superintendent to offer employment and issue contracts for approved positions with the approval of the Board Chairman prior to the Board meeting and approving the appointment. This exception is to only be used in cases where a delay in filling the position causes an undue hardship on the division or puts it at a competitive disadvantage witha potential candidate. Such appointments are subject to confirmation by the entire School Board at its next meeting. This resolution shall remain in effect until December 31, 2024 with the expectation that it will be reintroduced at the organizational meeting each year.
